

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hours on 2081/07/14 (30/10/2024) at the Chamunda Bindrasaini Municipality, Dailekh

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs 292,000.00, which shall be valid for 30 days beyond the validity period of the bid.
